Re : Application for Scholarship for Doctor of Philosophy Program in Medical Physics and Medical Engineering (International Program) of the Academic Year 2023 (For the Project "Development of Research and Development Talents in Medical Physics and Medical Engineering", Academic Year 2023 - 2028)

Princess Srisavangavadhana College of Medicine, Chulabhorn Royal Academy, has considered the application for a scholarship for the Doctor of Philosophy Program Medical Physics and Medical Engineering (International Program) of the academic year 2023 to develop students in teaching and learning, research, as well as expanding equally educational opportunities for students.

By virtue of Section 32 of Chulabhorn Royal Academy Act B.E. 2559 and its amendments accompanied by Order of the Chulabhorn Royal Academy Special 8/2566 Re: Authorization for Operations of Chulabhorn Royal Academy, Chulabhorn Royal Academy Announcement on Application for Scholarship for Doctor of Philosophy Program in Medical Physics and Medical Engineering (International Program) of the academic year 2023 (For the Project "Development of Research and Development Talents in Medical Physics and Medical Engineering", Academic Year 2023 - 2028) is therefore announced with the following details:

1. Eligible scholarship applicants:

1.1 The scholarship recipient shall study in Doctor of Philosophy Program in Medical Physics and Medical Engineering (International Program).

1.2 The scholarship recipient shall have qualifications according to the details attached with the announcement of Princess Srisavangavadhana College of Medicine on application for admission to the Doctor of Philosophy Program in Medical Physics and Medical Engineering (International Program) Academic Year 2023 (No. 2)

1.3 The scholarship recipient shall not be in the process of receiving scholarships for graduate studies from other sources of funding.

2. Fund type and fund allocation:

The scholarship shall waive the actual costs of tuition fees, educational maintenance fees, and educational fees (admission fee and student ID card fee). Types of Scholarships are as follows:

2.1 The scholarship for students in Plan 1.1 is allocated for 3 years of no more than 400,000 baht per scholarship.

2.2 The scholarship for students in Plan 1.2 is allocated for 4 years of no more than 550,000 baht per scholarship.

3. Period of scholarship:

3.1 Doctoral students in Plan 1.1 are allocated for a period of 3 years.

3.2 Doctoral students in Plan 1.2 are allocated for a period of 4 years.

4. Period of application:

A scholarship application form submission from now on until 8 June 2023.

5. Criteria and conditions for receiving scholarships:

5.1 The scholarship recipient shall study in the Doctor of Philosophy Program in Medical Physics and Medical Engineering (International Program).

5.2 The scholarship recipient shall be polite and have good behavior without a history of misconduct, suspension or being suspended from studies, or missing any exams.

5.3 The scholarship recipient shall not in the process of receiving scholarships for graduate studies from other sources of funding.

5.4 Within the scholarship period, a study report and thesis progress report shall submit during the scholarship period with the approval of the Program Administrative Committee to Princess Srisavangavadhana College of Medicine at the end of each semester.

5.5 Within the scholarship period, at least two research articles shall publish in an international academic journal listed in the Scopus or PubMed databases. The scholarship recipient shall be the first author and the research articles must be a part of the doctoral thesis. The scholarship recipient shall publish the research articles on behalf of Chulabhorn Royal Academy, as well as specify the scholarship in the acknowledgment of the research articles. This also applies to the scholarship recipient who does not receive the scholarship for the entire duration of the contract.

5.6 Before graduation, the thesis abstract, approval page, and acknowledgment shall be submitted as PDF files, and the scholarship shall specify in the thesis acknowledgment. This also applies to the scholarship recipient who does not receive the scholarship for the entire duration of the contract as well.

5.7 The scholarship recipient shall enter into the scholarship contract with Chulabhorn Royal Academy and provide a suretyship according to the form and method specified by Chulabhorn Royal Academy.

6. Scholarship repayment

If the scholarship recipient does not comply with the conditions for the scholarship, the Royal Academy has the right to terminate the scholarship contract. The scholarship recipient agrees to repay the money received during the study period under this project to the Royal Academy within the period specified by the Royal Academy. In case

of non-compliance, if the reason is of utmost importance, the scholarship repayment scheme will be considered by the scholarship committee.

7. The suspension of the scholarship contract

Princess Srisavangavadhana College of Medicine will suspend the scholarship when:

7.1 The student status of the scholarship recipient terminates.

7.2 The scholarship recipient has an examination result of lower than S level for 2 consecutive semesters.

7.3 There is no progress in thesis work according to the opinion of the Program Administrative Committee.

7.4 The scholarship recipient terminates or takes a leave of absence from study without reasonable grounds.

7.5 The scholarship recipient commits fraud in the examination or plagiarizes the academic work of others.

7.6 Scholarship Committee has considered and deemed it appropriate to suspend the scholarship.

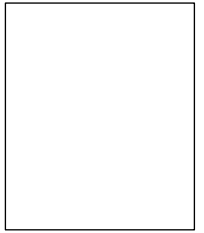

For the order, appropriateness, and efficiency of scholarship granting of Princess Srisavangavadhana College of Medicine, Chulabhorn Royal Academy for students of Doctor of Philosophy Program in Medical Physics and Medical Engineering (International Program), academic year 2023 - 2028 as well as for promotion and support for students of Princess Srisavangavadhana College of Medicine to complete the doctor of philosophy degree,

By virtue of Section 22(2) of Chulabhorn Royal Academy Act B.E. 2559 and its amendments accompanied by the resolution of the meeting of Chulabhorn Royal Academy Council No. 3/2023, dated 17 March 2023. Secretary General of Chulabhorn Royal Academy authorized by Chulabhorn Royal Academy Council therefore announced the following details:

Clause 1 This announcement is called "Criteria and Conditions for Scholarship for Doctor of Philosophy Program in Medical Physics and Medical Engineering (International Program) For the Project "Development of Research and Development Talents in Medical Physics and Medical Engineering", Academic Year 2023 – 2028".

Clause 2 This announcement will come into force from semester 1, academic year 2023.

Clause 3 In this announcement:

"The Royal Academy" means Chulabhorn Royal Academy.

"Secretary-General" means the Secretary-General of Chulabhorn Royal Academy.

"Dean" means the Dean of Princess Srisavangavadhana College of Medicine.

"Scholarship" means educational scholarship, including waiver of tuition fees, educational maintenance fees, and educational fees for Doctor of Philosophy Program in Medical Physics and Medical Engineering (International Program), academic year 2023 – 2028.

"Scholarship Committee" means the Scholarship Committee of Doctor of Philosophy Program in Medical Physics and Medical Engineering (International Program), academic year 2023 – 2028.

CHAPTER 1

Objectives

Clause 4 Objectives:

(1) To encourage and provide opportunities for talents with research potential to study in Doctor of Philosophy Program in Medical Physics and Medical Engineering (International Program) to help driving medical industries and medical service of the country and the region by waiving the tuition fees, educational maintenance fees, and educational fees for the aforementioned field of study.

(2) To encourage students of Doctor of Philosophy Program in Medical Physics and Medical Engineering (International Program) of Princess Srisavangavadhana College of Medicine, Chulabhorn Royal Academy to produce internationally recognized research.

CHAPTER 2

Qualifications of Eligible Scholarship Applicants

Clause 5 Eligible scholarship applicants:

(1) Must be admitted to study in Doctor of Philosophy Program in Medical Physics and Medical Engineering (International Program).

(2) Must be polite and have good behavior without a history of misconduct, suspend or being suspended from studies, or missing any exam.

(3) Must not be in the process of receiving scholarships for graduate studies from other sources of funding.

CHAPTER 3

Scholarship Committee

Clause 6 The scholarship committee comprises the Dean of Princess Srisavangavadhana College of Medicine as the chairman, one vice-chairman, associated persons of Princess Srisavangavadhana College of Medicine of no more than 3 persons as the committee members, and the Deputy Dean responsible for this issue as the committee member and secretary.

Clause 7 Powers and duties of the scholarship committee are as follows:

(1) Set guidelines for the fund allocation of the program.

(2) Consider and select scholarship recipients.

(3) Consider criteria for expenses of scholarship recipients and duration of study.

(4) Consider and decide the funding, suspension, and revocation of the scholarship.

(5) Monitor and assess the scholarship recipient.

(6) Perform other duties as assigned.

CHAPTER 4

Scholarship type, allocation, and period

Clause 8 Fund type and fund allocation:

The scholarship waives the actual costs of tuition fees, educational maintenance fees, and educational fees (admission fee and student ID card fee). Types of Scholarships are as follows:

8.1 The scholarship for students in Plan 1.1 is allocated for 3 years of no more than 400,000 baht per scholarship.

8.2 The scholarship for students in Plan 1.2 is allocated for 4 years of no more than 550,000 baht per scholarship.

Clause 9 Scholarship period:

9.1 Doctoral students in Plan 1.1 are allocated for a period of 3 years.

9.2 Doctoral students in Plan 1.2 are allocated for a period of 4 years.

CHAPTER 5

Criteria and conditions for receiving scholarships

Clause 10 Criteria and Conditions for receiving scholarships are as follows:

(1) The scholarship recipient shall study in Doctor of Philosophy Program in Medical Physics and Medical Engineering (International Program).

(2) The scholarship recipient must be polite and have good behavior without a history of misconduct, suspension or being suspended from studies, or missing any exam.

(3) The scholarship recipient must not be in the process of receiving scholarships for graduate studies from other sources of funding.

(4) Within the scholarship period, a study report and thesis progress report must be submitted during the scholarship period with the approval of the Program Administrative Committee to Princess Srisavangavadhana College of Medicine at the end of each semester.

(5) Within the scholarship period, at least two research articles must be published in international academic journals listed in the Scopus or PubMed databases. The scholarship recipient must be the first author and the research articles must be a part of the doctoral thesis. The scholarship recipient must publish the research articles on behalf of Chulabhorn Royal Academy, as well as specify the scholarship in the acknowledgment of the research articles. This also applies to the scholarship recipient who does not receive the scholarship for the entire duration of the contract.

(6) Before graduation, the thesis abstract, approval page, and acknowledgment must be submitted as PDF files, and the scholarship must be specified in the thesis acknowledgment.

This applies to those who do not receive the scholarship for the entire duration of the contract as well.

Clause 11 The scholarship recipient must comply with the Regulations of Chulabhorn Royal Academy on Management of Intellectual Property and Innovation of Chulabhorn Royal Academy, Intellectual Policy, and related practices.

CHAPTER 6

Scholarship Contract and Suspension of Scholarship Contract

Clause 12 The scholarship recipient is required to sign a scholarship contract with the Royal Academy with a guarantor according to the forms and methods determined by the Royal Academy.

Clause 13 The suspension of the scholarship contract is as follows:

(1) The student status of the scholarship recipient terminates.

(2) The scholarship recipient has an examination result of lower than S level for 2 consecutive semesters.

(3) No progress in thesis work according to the opinion of the Program Administrative Committee

(4) The scholarship recipient terminates or takes a leave of absence from study without reasonable grounds.

(5) The scholarship recipient commits fraud in the examination or plagiarizes the academic work of others.


(6) The Scholarship Committee has considered and deems it appropriate to suspend the scholarship.

Clause 14 If the scholarship recipient does not comply with the conditions for the scholarship, the Royal Academy shall have the rights to terminate the scholarship contract. The scholarship recipient agrees to repay the money received during the study period under this project to the Royal Academy within the period specified by the Royal Academy.

In case of non-compliance, if the reason is of utmost importance, the scholarship repayment scheme will be considered by the scholarship committee.

Clause 15 The Secretary-General shall be in charge under this announcement and shall have the power to issue orders or set criteria as a practical guideline as well as interpret and diagnose problems related to the practices according with this announcement. The decision of the Secretary-General shall be final.
